POSITION: Lifeguard

Supervisor: Aquatics Director

GENERAL FUNCTION:

Under the supervision of the Aquatics Director, the lifeguard will supervise the pool and serve in accordance with rules and policies as set forth by the Ashland YMCA.

ENTRY REQUIREMENTS:

The incumbent must bring to this position a minimum of Lifeguard Certification (Red Cross, or preferably YMCA Lifeguard), a current CPR for the Professional Rescuer Certification, a current Standard First Aid Certification, have or obtain a thorough understanding of facilities emergency procedures, and have Blood Borne Pathogen training as required by OSHA guidelines. <u>Must pass a pre-employment drug test</u>. Must pass a security clearance.

ESSENTIAL FUNCTIONS OF JOB:

- 1. Ability to establish and maintain harmonious relationships with both members and staff.
- 2. Visual and auditory ability to respond to critical incidents and the physical ability to act in an emergency situation.
- 3. Ability to adequately observe participant activities, enforce safety regulations, and apply appropriate management techniques.
- 4. Ability to provide high quality customer satisfaction to members while performing your job.
- 5. Ability to meet goals and objectives of the Ashland YMCA through its mission.

JOB SEGMENTS:

- 1. Enforce and follow general pool rules as set forth by the Association at all times.
- 2. Supervise lap swimming and oversee all activities in the pool, ensuring the safety of everyone.
- 3. Keep the pool area clean and orderly, removing unnecessary items from the pool deck.
- 4. Assume responsibility during an emergency situation and follow emergency procedures.
- 5. Attend all required meetings and in-service trainings.
- 6. Providing YMCA members with general rules and guidelines for safety and general information and keeping a good rapport with the members.
- 7. Keep accurate statistics of program attendance and general pool use.
- 8. Be attentive to each member who enters the pool: greet each person, assess physical limitations and monitor behavior while in the pool area.
- 9. Lifeguards shall work scheduled shifts, arriving on time and staying the full length of the shift unless otherwise told by supervisor. Find a substitute when gone and have all absences pre-approved by supervisor.
- 10. Dress according to the staff uniform policy: red, black or blue shorts and lifeguard shirt, no jewelry, long hair restrained.
- 11. Follow specific staff policies outlined by the YMCA and supervisor.
- 12. Perform other duties as assigned.
- 13. Assist in special events, when required.
