



**Job Title: Afterschool Care Counselor
(Part-time, Hourly)**

ESSENTIAL DUTIES AND RESPONSIBILITIES

- Responsible for helping to supervise program participants at our Afterschool Care sites and is actively engaged with program participants. This includes playing games with the kids, helping with homework, etc.
- Ensure all children are aware of and follow all rules and daily scheduled routines.
- Demonstrates a working knowledge of the YMCA childcare policies and follows procedures including those related to medical and disciplinary situations, child abuse prevention and emergency procedures.
- Maintains program site and equipment, and assists with the set up and tear down of activities.
- Ability to follow, lead and participate in lesson plans designed by the site supervisor in a variety of indoor and outdoor settings.
- Regularly communicates with and takes direction from site supervisor and Youth Activities Director.
- Communicates with site supervisor, coworkers, and Youth Activities Director about program participants and addresses any behavioral issues.
- Required to upkeep the cleanliness of the facility, including but not limited to sweeping, mopping, washing the dishes, taking out the trash, etc.
- Required to maintain records, including but not limited to incident reports and unacceptable behavior reports. Assists with additional administrative duties as assigned.

JOB DUTIES

- Maintain punctual, regular, and predictable attendance.
- Must be responsible and pay attention to details.
- Able to work alone as well as collaboratively in a team environment with a spirit of cooperation.
- Maintain a positive image at all points of contact with members of the public.
- Assist site supervisor with specific tasks as assigned.
- Maintain professional attitude and manner and respectfully take direction from supervisor.
- Must commit to working School's Out Days during the school year.
- Perform other duties as assigned.

QUALIFICATIONS

- Must successfully pass a security clearance.
- Education in youth development, elementary/secondary education or equivalent, preferred
- Previous experience working with children in a childcare, camp, or classroom setting, preferred
- CPR certification and Child Abuse Prevention training within 30 days of hire date
- Must be enrolled in the Oregon Office of Childcare's Central Background Registry
- Previous experience with diverse populations is preferred; the ability to develop positive, authentic relationships with people from all backgrounds

- Good communication and interpersonal skills
